

Sacramento Dog Training Club: January 2025

Thank you for entering Sacramento Dog Training Club Rally / Obedience Trial.

IMPORTANT: IF YOU HAVE MULTIPLE DOGS ENTERED AND YOUR ARM BAND NUMBERS ARE CONSECUTIVE, THE RUNNING ORDER HAS BEEN FIXED ON THE GATE SHEETS.

There **will/may be** a parking fee collected each day at the gate: \$5, in the past, but bring a little extra just in case.

Please check the AKC number and class/s your dog is entered in: Move-ups are not necessarily reflected in Judging schedule.

Refer to sacramentodtc.org for final marked catalog and additional copies of judging program, RALLY MAPS if available to release early and confirmation letter.

RALLY - Friday Judge to take lunch at their discretion.

Trial 2 - **GREEN:** Gina Grissom start time 9:00 **Tall to Small Walk-thru 8:50**

Trial 1 - **BLUE:** Jame Comunale start time 9:30 **Small To Tall Walk-thru 9:20**

- If the Rally courses are available the night before, they will be posted on sacramentodtc.org after 6 pm, otherwise, they will be available as copies or posted the day of the trial
- If you are in both Trial Blue and Trial Green • Trial Green will start 30 minutes before Trial Blue.
- Depending on the number of exhibitors the walk throughs may be divided into groups.
- WITH A CONCURRENT TRIAL SCHEDULE - It will NOT BE POSSIBLE to move up between RALLY Green and RALLY Trial as the 'move up' class will have already run.

RALLY and OBEDIENCE General procedures

- **CHECK IN:** Envelopes with your arm bands FOR THAT DAY ONLY will be on a table. And please mark yourself present on the gate sheets.
- Every effort has been made to adjust running order to avoid conflicts; If necessary, Ring Stewards will help moving a dog due to a ring or dog order conflict. Conflicts may run at the end of the class.
- Move ups are allowed before the trials start on Friday and up to 30 minutes before the new Obedience class on Saturday and Sunday but it would be very helpful if we knew the night before. You will find move up sheets on the check in table. Remember that move-ups are run at the end of the class.

Ring Set Up and Crating

- Crating will be in designated areas in the arena or outside the arena. Per facility requirements only crates may be placed on the artificial turf, X-pens are not allowed - canopy may be helpful if crating outside. Crating can not be done earlier than 3 pm Thursday.
 - Any dog creating a disturbance (in the opinion of the trial committee) or reacting to other dogs passing their crates will be required to move outside the building.
- Per facility policies; if crating outside on the grass, any mats set up on the grass need to be removed each day when you leave for the day.

Awards

- Placement ribbons will be done at/in each ring.
- Double /Triple Q pins and Title completed ribbons will be at each ring table.
- The judging book will be posted on the board and will also be posted on-line after the trial on SacramentoDTC.org

Just FYI

- There is no food available on site and there will not be any hospitality coffee or water available except for ring crew and judges.
- Marked catalogs will be available on our website sacramentodtc.org after the trial. Several copies of the catalog will be the check in table for reference.
- NO CORRECTIONS OR INTENSIVE TRAINING are allowed in the parking lot, in the warm-up ring or on the trial grounds.
- MOST IMPORTANT: PLEASE BE PATIENT WITH THE CREW, JUDGES AND FELLOW EXHIBITORS.

DIRECTIONS TO SITE

FROM I-5 - Take Hwy 12 East toward Lodi, for 1.6 miles, to Ray Road. Turn left on Ray Rd. Proceed for 1 mile to curve in road and turn left toward Sycamore Lane Kennels. Follow Signs to Sycamore Lane Kennels.

FROM HWY 99 -Take Hwy 12 exit West (Kettleman Lane) toward Lodi. Go through Lodi about 5 miles to Ray Rd and turn right. Proceed for 1 mile to curve in road and turn left toward Sycamore Lane Kennels. Follow Signs to Sycamore Lane Kennels
