Parameters of the Tracks

400 Yards	1 obstacle
3-5 turns	1 intermediate article (plus start and end)
1 cross track	Aged 3 hours

There will be a semi-random draw for running order as we need to coordinate those running a dog and laying a track for somebody else.

Prerequisites – your dog must have earned a TD or TDU prior to this match and be comfortable working at three (3) hour track age.
